REPORT OF THE COMMISSIONER, BHUBANEWSWAR MUNICIPAL CORPORATION, BHUABANESWAER.

The Humble Report of the Commissioner, Bhubaneswar Municipal Corporation Most Respectfully sheweth:

- That the aforesaid case has been filed by Sri T.K Dwibedi 1. before the Hon'ble Court of Odisha Human Rights Commission alleging that 23 nos of Dibyanga street vendors have Illegally and arbitrarily evicted from the Market Bullding area without proper rehabilitation for which their Human Rights as well as constitutional rights have been violated.
- 2. That after receipt of the Notice from the Hon'ble Odisha Human Rights Commission, Bhubaneswar the matter was enquired by the Deputy Commissioner, (Vending Zone), Bhubaneswar Municipal Corporation and the following observations are submitted.

- That as per the field inquiry report on the allegation of the petitioners "Dibyanga Street Vendors " for eviction inside the Market Building Area without rehabilitating them it is humbly submitted that the vendors who were doing business inside the Market Building Area were evicted due to traffic congestion and sanitation hazards.
- 4. That the Central Market Association of Market Building has signed an agreement with the Bhubaneswar Municipal Corporation, Bhubaneswar not to issue any permission for business by mobile vendors inside the market building area which has been declared as a "NO VENDING ZONE".
- 5. That the Bhubaneswar Municipal Corporation has also declared that the area of the Market Building and all roadside footpaths of BMC as a "NO VENDING ZONE" for the greater interest of the General Public.

Submission of reports on OHRC case no.621/2024 filed by T. K Diwedi and Others

As per the direction of the Hon'ble Court, the matter has been inquired in the field and the following observations are submitted.

As per the filed inquiry report on the allegation of petitioners "Dibyanga Street Vendors" for eviction inside the Market Building area without rehabilitating them. The vendors who were doing business inside the Market Building area were evicted due to traffic conjunction and sanitation hazards of that area. The Central Market Association of Market Building has signed an agreement with BMC not to issue any permission for business by mobile vendors. The Bhubaneswar Municipal Corporation has also declared the area of the market building and all roadside footpaths of BMC as a "NO VENDING ZONE" for the greater interest of the general public. The allegation made by the petitioner is false and fabricated. After the eviction of disabled vendors inside the Market Building, BMC has allowed space for 23 nos. of disabled persons near the Market Building area to do temporary business till an alternate arrangement is made (document enclosed). Further, BMC is doing its best to allot kiosks to eligible differently able persons, whenever any vending zone is constructed. The BMC Authority has never assured any person to allot kiosks at the Ghatikia vending zone.

The disabled persons who are allowed space near the Market Building are continuing in that space. BMC has not taken any steps for eviction from that space. As per the inquiry report, it is found that out of 23 vendors, some differently able vendors are still doing business and they have no objection (report enclosed). It is also found from the verification report that, some of the vendors have sold their space to general vendors. The petitioners are demanding a differently able persons immediately. It can only be possible in a phased manner on the availability of shops.
