Decision

- 1. The case is taken up today i.e on 14.08.2024. The appellant has requested to provide audio video mode for hearing of appeal. However the same cannot be entertained as no such facility is available in this office. Hence hearing of the case is taken up in physical mode.
- **2.** The appellant T K Dwibedi is absent on call. The PIO is present and filed her hazira which is on the record.
- 3. On perusal of the appeal petition filed by the appellant, it is found that the appellant had filed Form-A application on dated 26.04.2024 seeking information regarding reason for the non compliance of section 4 (1) (b) of the RTI Act, 2005 by not uploading and publishing the telephone number, mobile number, WhatsApp number and email address of all the officers in the official website and RTI portal.
- 4. The PIO in her submission stated that the available information regarding compliance of section 4(1) (b) was supplied to the applicant vide this office Letter No. 10760/OHRC dtd 27.05.2024 through online mode within 30 days of receipt of the application.

- 5. Taking into consideration the discussion made above, I am of the view that the necessary information as available has duly been supplied by the PIO to the applicant within the stipulated period of time prescribed under RTI Act, 2005.
- 6. With the above observations the appeal case 03/2024-25 is hereby disposed of accordingly. Copy of this decision be communicated to the appellant and the PIO for information and necessary action. However if the appellant feels aggrieved by this decision, he may file second appeal before the State Information Commission as per the provisions of RTI Act.
