this crime spree. Instead, the recommendation for a receipt system for the hospital has been made without any efforts to recover the stolen vehicles or investigate the matter thoroughly. Police Syndicate with Antisocial: My interaction with ACP Tapas Pradhan has revealed a dismissive attitude towards the recovery

of my motorcycle. He claimed that my motorcycle's engine had been used in a boat but failed to take any further action or hold anyone accountable for this alleged crime, indicating a disturbing level of corruption and negligence in the police department. The ACP and others categorically stated to the victim that the bike had been dismantled and the engine was used in a Boat so he should not keep any hope for the recovery of the bike thus proving the syndicate of the police department with the antisocial which caused the society and the city of Bhubaneswar is not safe in the hands of Commissionerate police and its corrupt officers. This ACP also caused the murder of the convicted prisoner Sk Haedar of Kendrapara, Bharat Mandal of Cuttack, and many more in 2021 but still holding an ACP post in the police department violating the rule of law. Given these circumstances, I respectfully request that the Odisha Human Rights Commission investigate these allegations of police inaction and corruption at the Bharatpur Police Station. The failure to register my FIR and the unresponsiveness from higher authorities undermine my basic rights and the rights of others who have suffered similar injustices. I hope that the OHRC will take swift action to ensure that accountability is upheld and that victims of crime in Bhubaneswar can seek justice through the proper channels without fear of collusion or corruption. Thank you for your attention to this pressing matter. I hope you will take prompt action to ensure justice and maintain the law.
