Incident Details:	<p>This is to inform you that one crime was registered on 23-08-2017 at the Khumharpada PS of Puri. Still, the IO filed a charges sheet after three years under a deep-rooted criminal conspiracy, intentionally, dishonestly, fraudulently, and for the wrongful gain and deceitful means caused injury to the victims. 01. That, the police stations and IO did not file a charge sheet till the victim's minor girl had attained the majority till the completion of the negotiation between the victims and the accused, and till the marriage had been solemnized between the victim and accused thus running a parallel office of bargaining in the police station for money and the wrongful gain as the District Police Department is running on the principles of profitability and return on investment as the post and police stations are bought and sold. For the same, the police stations are converted into torture and extortion centers as the SP and DM are not inspecting the police stations of the district under the Odisha PMR No. 37(a) and 21 respectively. The same is done under a deep-rooted criminal conspiracy, intentionally, dishonestly, fraudulently, and for wrongful gain and deceitful means that has caused injury to many. 01. That, the District Prosecution department is filled with incompetent, impotent, and powerless public prosecutors who are the products of letter pad law colleges who managed to secure a law degree by unfair means and enrollment of the BAR by paying a bribe of Rs.42,000/- instead of Rs.750/- 02. That, the no district acquittal review committee has been formed or run as per the law in the Puri District as the SP and others are engaged in the illegal collection of money from all possible quarters making the lives of the minor girls of the district a hell. 03. That, presiding officer of the POCSO court is also taking his share from the illegally collected bounty from the accused and the amount of the victim compensation scheme and facilitating the acquittal of as 35 years old man who committed raped in the 15 years old minor girl multiple times and ruined her life. 04. That, for three years the minor girl and her parent were compelled to negotiate with the accused or face consequences in the future as the accused was well connected with the ruling political party and openly threatened the victim by saying "MU BJD BALA MORA KIYE KAN KARIBA" 05. That, the District administration and judiciary failed miserably to achieve the object of the POCSO Act for the wrongful gain that must be investigated for the pass occurrence and stopped for future occurrence. 06. That, the right of the victim minor girl has been violated as the rape is committed on her multiple time, then she was compelled to compromised with the accused and them marriage to the rapist forcefully</p>
