Gangadhar Saseni (54) S/o Balaram Saseni of Vill: Bantunia, PO-Bentkar, PS: Sadar, Dist: Cuttack, AVPr- DIB Insp. of Cuttack UPD, presented a written report that today i.e., on 24.07.21 in obedience to the order of J.M.F.C., (C) Cuttack, he along with SI Asit Ranjan Jena, H/M Gajendra Nath Soren, Hav. Surya Kumar Rout, C/145 Soumya Ranjan Rout, C/166 Satyajit Swain, C/712 Rohit Kumar Mallick, C/179 Purusottam Rout, C/314 Rajendra Nayak C/337 Kalpataru Nayak were commanded vide C.C. No.0556714 to escort one convict namely Sk. Hyder @ Sk. Hyder Alli S/o-Sk. Ayub of Ranapada, PS-Kendrapada, Dist-Kendrapada from Circle Jail Cuttack at Choudwar to Circle Jail Baripada on security point of view. Accordingly they reached at Circle Jail, Cuttack at Choudwar at 11:55 AM and received the above convict for shifting. Since he was a dreaded criminal and previously had escaped from the SCB MC H, Cuttack while undergoing treatment, they hand cuffed the convict as a precaution measure to guard against any attempt to escape. They left Choudwar at 12:40 PM in police vehicle bearing regd. No.OD-05D-6144 being driven by Driver Hav. Debananda Jena. While they were travelling near at Simulia at about 03:20 PM, the said Hyder told him to stop the vehicle to attend the call of nature. He along with his staff dissuaded Sk. Hyder not to stop the vehicle from his security points of view. But the said Hyder became rigid and told that he is suffering from acute diabetic so he has to attend the call of nature. So they stopped the vehicle at a diversion point near one Hanuman Temple at Simulia. Hyder along with the escort party got down from the vehicle. With reference to the subject cited above I Sri Gangadhar Saseni, Insp. UPD Cuttack, beg to report that at present I am serving as Inspector DIB, Cuttack UPD Cuttack. Today i.e., on 24.07.21 in obedience to the order of J.M.F.C., (C) Cuttack, I along with SI Asit Ranjan Jena, H/M Gajendra Nath Soren, Hav. Surya Kumar Rout, C/145 Soumya Ranjan Rout, C/166 Satyajit Swain, C/712 Rohit Kumar Mallick, C/179 Purusottam Rout, C/314 Rajendra Nayak & C/337 Kalpataru Nayak were commanded vide C.C. No.0556714 to escort one convict namely Sk. Hyder @ Sk. Hyder Alli S/o-Sk. There was reasonable apprehension of death / grievous hurt of the escort party members from the side of the convict as he was desperate to open fire upon the escort party to kill all of them. In such a dangerous situation of life and death and in exercise of the right to private defense and to save the life of police personnel from imminent danger of death Sri Asit Jena fired three rounds from his service pistol to prevent him from any attack. He took all precautions to resort to controlled fire to hit in the lower part of the body below the waist of the convict Sk. Hyder with a view to immobilize him and to prevent him from opening fire which endangered to the life of all police

personnel. Had there not been firing from the side of escort party to prevent his escape and to save the life of escort party members, the convict could have killed the escort party members by firing from the AK-47 gun that he had already snatched away from Havildar Surya Kumar Rout. The bullet hit on the left side upper arm and on the body of the convict, as he bent down all of a sudden to open fire towards police as a result of which he fell down on the ground. He was over captured by the escort team and the gun (AK-47) was recovered from him. As the convict sustained bleeding injuries we took all the sincere steps to save his life and he was immediately shifted to DGH Bhubaneswar for his treatment. While shifting the convict to hospital enroute I have intimated about the incident to my seniors. Subsequently I came to know that the said convict Sk. Hyder died during treatment.

The said convict was a disparaging and horrendous criminal and a series of cases were registered against him. He was also convicted in different cases.

Under the above circumstances I lodged this FIR for taking necessary action at your end.

He as well as SI Sri Asit Jena warned him in loud voice for his surrender before police which was unheeded by Sk. Hyder. There was reasonable apprehension of death / grievous hurt of the escort party members from the side of the convict as he was desperate to open fire upon the escort party to kill all of them. In such a dangerous situation of life and death and in exercise of the right to private defense and to save the life of police personnel from imminent danger of death Sri Asit Jena fired three rounds from his service pistol to prevent him from any attack. He took all precautions to resort to controlled fire to hit in the lower part of the body below the waist of the convict Sk. Hyder with a view to immobilize him and to prevent him from opening fire which endangered to the life of all police personnel. Had there not been firing from the side of escort party to prevent his escape and to save the life of escort party members the convict could have killed the escort party members by firing from the AK-47 gun that he had already snatched away from Havildar Surya Kumar Rout. The bullets hit on the left side upper arm and on the body of the convict, as he bent down all of a sudden to open fire towards police as a result of which he fell down on the ground. He was over captured by the escort team and the gun (AK-47) was recovered from him. As the convict sustained bleeding injuries they took all the sincere steps to save the life of Sk. Hyder and immediately shifted him to DHH Balasore for his treatment. While shifting the convict to hospital enroute he intimated about the incident to his seniors. Subsequently he came to know that the said convict Sk. Hyder died during treatment. The said convict was a disparaging and horrendous criminal and a series of cases were registered against him. He was also convicted in different cases. Under the above circumstances he lodged this FIR for taking necessary action.
