Sir,

This is to inform you that the RTI application dated 25-10-2024, which was transferred to you from the PIO, DCP, Cuttack, was not redressed in time, as per the rule of law, directions of the competent authority(s), and guidelines of the apex court.

- 01. The same is disposed of after 93 days, but the rule mandates only 30 days as you were found absent from duty and were negotiating with the members of the Marawari Samaja in your official chamber for wrongful gain.
- 02. That, the reply Dt. 27-01-2025 is cryptic and you have concealed the fact under a deceitful means as to whether the reports are with you or not it is not clear from your reply where other police stations did not possess the same.
- 03. That, the PIO has concealed the fact that the report Dt. 18-08-2017 was sent through registered post and you have concealed the fact that the same has been stolen from the police station which is a public document.
- 04. That, the PIO failed to state how you concluded that none has submitted the report on Dt. 18-08-2017
- 05. That, the PIO has concealed your contact details so that no one can file a recall or review petition.
- 06. That, the PIO has not created any ID so that no one can file an appeal through online mode.
- 07. That, the PIO has not complied with the provision of the Odisha Right to Public Service Act -2012 and the direction of the chief Secretary Mr. Manoj Ahuja considering yourself above the law.
- 08. That, the PIO has not complied with the directions of the Government of Odisha issued to all PIOs vide notification No. 18311 Dt. 22-11-2023.
- 09. That, the petitioner has reason to believe that the PIO has relinquished his duty and has sublet his work to any junior staff who is impersonating as PIO and disposing of the RTI application illegally and arbitrarily as the PIO voluntarily confessed of the same during the telephonic conversation.
- 10, That, the petitioners being the practicing lawyers of the Hon'ble Orissa High Court have reason to believe that the same has been done under a deep-rooted criminal conspiracy, intentionally, dishonestly, fraudulently, and for the wrongful gain as the deceitful means has caused injury to many.

So you are requested to recall the order, comply with the rule of law, and compensate the victims adequately for the injury caused due to the deceitful means or be ready to face the law of the land as the PIO and other erring officers are not above the law.

I hope you will take prompt action to ensure justice and to adhere to the rule of law prevailing in the country.
