

Sir,

With reference to the letter on the aforesaid subject it is to bring to your kind notice that I went through the petition filed by the above noted petitioner and enquired into it. During my enquiry it is ascertained that Tapaswini Dash D/o- Kishore Chandra Das of Devi Nagar 1st Lane Chhatrapur and Sumit Kumar Sahu, S/o- Pramod Kumar Sahu of Ganesh Nivas Brahmanagar 2nd Lane have registered their marriage in the family court Bhubaneswar on 07-09-2020 following love affairs. They went to PURI and informed their parents for accepting them as husband and wife as they were not aware of the marriage. After discussion Tapaswini Dash came to the house of Sumit Kumar Sahu along with him and both stayed as husband and wife for about two months. Due to matrimonial dispute Tapaswini Dash left her in-law's house and stayed in her parent's house at Chhatrapur. Thereafter family members of Tapaswini Dash pursued for solemnization of marriage as per Hindu Custom with Sumit Kumar Sahu. But the family members of Pramod Kumar Sahu including Sumit did not agree for the same. In the month April 2021 Tapaswini Dash lodged FIR at Mahila PS Berhampur against her husband and in-laws narrating the fact. In this connection IIC Mahila PS took steps for counselling and called Sumit and his parents but neither Sumit nor his parents turned up for counselling. Tapaswini Dash and her father urged for registration of case with a hope that Sumit and his family members may bow down and agree for the marriage but it did not happen. Subsequently IIC Mahila PS registered Mahila PS Case NO 57 Dt 19.04.2021 U/s 498(A) / 294/323/506/ 34 IPC. After completion of the investigation, the case was charge sheeted vide CS No. 86 dt. 30.07.2021 U/s 498(A)/394/323/506/34 IPC R/w section 4 DP Act against Sumit Kumar Sahu, Pramod Kumar Sahu and Smita Rani Sahu. Now the case is sub-judiced in the court of SDJM Berhampur. Sumit Kumar Sahu has filed a matrimonial suit in the court of Family Judge Berhampur vide CP NO. 334/2021. Honourable Judge of family court has issued summon to Tapaswini Das for her appearance in the court on 01.12.2021. After receiving the notice Tapaswini Dash and Pramila Tripathy reached in front of the house of Pramod Kumar Sahu and sat in front of the house of Pramod Kumar Sahu to highlight her cause. Soon after Tapaswini Dash started making demonstration in front of the house of the complainant Smitarani Sahu, the husband of the complainant Pramod Kumar Sahu, son Dr. Sumit Kumar Sahu and Pramit Kumar Sahu stopped visiting the house. There were presence of prints and electronics media and public day and night in front of the house of the complainant. The complainant Smitarani Sahu and her mother in law Bibasini Sahur emained inside their house and did not dare to come out from their house though there was no protest by Tapaswini Dash and her family members of their movement from the house. The husband of the complainant Pramod Kumar Sahu and her sons were not visiting their house apprehending embarrassment by the press people. Whenever the complainant and her mother in law were coming to the window grill in the first floor on 22 and 23.11.2021, Sri Manas Kumar Dash S/O Kishore Chandra Dash, and Kishore Chandra Dash S/O Late Biswanath Dash started abusing the family members of Pramod Kumar Sahu in slang language and threatened them of dire consequence.



On this issue on the written report of Smt Smitarani Sahu W/O Pramod Kumar Sahu of Ganesh Nivas, Brahmanagar 2nd Lane, Ps-B.N Pur ,Case No- CASE NO. 318 DT.24.11.2021 U/S 342/447/294/506/34 IPC was registered and after completion of investigation Charge Sheet has been submitted U/S 294/506/34 IPC against accused persons Kishore Chandra Dash(58) S/O Late Biswanath Dash and Manas Kumar Dash(19) S/O Kishore Chandra Dash both of Srinagar Sahi, (Devi Nagar) Chhatrapur, PS-Chhatrapur Dist-Ganjam vide CS No-15 Dt-30.01.2022.
