Incident Details:	<p>This is to inform you that the Odisha police and its subordinate offices & its officers are not redressing any complaint filed before then using the Janasunani Portal as nothing has been done to redress the complaint No. DG202290448 Dt. 05-09-2022 and the same has been closed illegally and arbitrarily just like an RTI application without providing any remedy to the victims and the final report was not communicated to the victim or complainants and the deceitful means of the police department has caused injury to many as for the information about the redressal of the complaint RTI application has to be filed by the complainants. 01. That, The complainants being the practicing advocates of hon'ble Orissa High court have reason to believe that no inquiry ever done, the EO. Never contacted with the victim or complainant during the inquiry and nothing has been done to collect the evidence from where it is available. 02. That, the all the police stations under the Berhampur have become the torture and extortion center as the SDPOs are not inspecting the police station as per the Odisha PMR No.32. the SPs are not inspecting the police station as per the Odisha PMR No.39. DMs & Other senior officers are not also inspecting the different PS and Offices at all. 03. That, the District Police Deptt. of Berhampur is not complying with the RTI act 2005, Right to Public Service Act, Whistleblower protection Act etc. The District Police Complaint Authority and the District Acquittal Review committee etc, are not running in the District as all are engaged in Vashooli and the same is confessed by the DGP Shri Y.V.Khurania vide PCO No.110 of 2024. 04. That, the SDPO has become the inquiry officer against the allegation labelled against him and against the SP violating the settled principle of law as no junior officer can be the inquiry officer against senior and against himself. which proves the grievance redressal machinery is failed in Odisha and people are not getting any remedies from the Govt. violating the provision of the Odisha Litigation policy.</p>
