That, nothing has been done to comply with the directions of the Apex court issued in the case of Kishan Chand Jail Vs UOI, W.P. civil No.360 of 2021 as no VC hearing ever provided to the complainant. 03. That, nothing has been done by the OIC, IPR Dept. to comply with the directions of the Hon'ble Orissa high Court issued in the case of Hemanta Nayak Vs State of Odisha , W.P. Civil No. 12399 Dt. 2024. 04. That, nothing has been done by the OIC to monitor/supervise the office of the Opp. parties of the CC No. 1438 of 2024 as per the provision of the section 25 of the RTI act-2005 and to comply with the guidelines of the apex court issued towards the same. 05. That, IPR Dept. is not redressing any complaint filed against the OIC and its erring public servants as the complaint Dt. 18-10-2025 filed was not yet redress thus violated the provision of the Odisha State Litigation Policy-2011. 06. That, the complainant has reason to believe that 1000 of other complaints are closed illegally and arbitrarily like this and no compensation as per the provision of the RTI Act even awarded to the aggrieved people and the same has been done under a deep-rooted criminal conspiracy, intentionally, dishonestly, fraudulently & for the wrongful gain and the deceitful means has caused injury to the masses. that, the new BJP Govt. ha removed the chairperson of the OSWC and OSCPCR on non-performance grounds but nothing has been done against the public officers of the IPR and OIC thus the Govt. of Odisha is discriminating between the people for the wrongful gain.</p>
