Subject: Complaint Petition against the Following Police officers of the Commisisonerate Police to operate the Paisa Vashooli Racket in collusion from the Bike lifters victim and others thus running the extortion racket while on police duty.

Respected Sir/Madam,

We, The practicing lawyers of the hon'ble Orissa High Court want to to bring to your kind attention towards the serious allegations of corruption, extortion, running of the Paisa Vaahooli Racket and illegal activities within Berhampur Circle Jail of Ganjam, Odisha . The following incidents have come to my notice, and I believe they warrant immediate investigation:

### 1. Extortion and Paisa Vashooli Racket:

- The FIR of the victim Dharendra Bhutia was not registered for 4 days even of the victim ran from pillars to pole
- The IIC refused to register the same u/s 173(1) of BNSS-2023
- The ACP refused to register the same u/s 30 of BNSS-2023
- The DPC refused to register the same u/s 173(4) of BNSS-2023
- The IIC demanded the bribe saying that there is no patrol in the police vehicle to run after the accused.
- The Bike lifter has not been arrested eve if the constable recognized him in CCTV footage.
- The police has nexus with the bike lifters as many bikes are stolen from the Amri Hospital premises but nothing has been done to curve the same
- 

### 2. Harassment and Violence:

- The victim was told that his bike is dismantled and the engine is used in a boat.
- The boat owner is not yet arrested.
- 

### 3. Forgery and cheating:

- When the matter was highlighted in media then after on the instigation of DCP and ACP , the police station registered the FIR on dt. 01-09-2024
- The victim was compelled to write the date of the incident as Dt. 30-08-2024 instead of 28-08-2024 to cover up their sin and to provide acquittal to the accused.

### 4. Inaction by Authorities:

- No foot patrolling to curve the bike lifting from the Amri Hosptial premises
- No token facility were adopted and advised by the police to the Hospital to curve the Bike Liftings

5. Sleeping Like KHUMBHAKARNA:

- The Bharatpur Police Station has become the torture and extortion center as one Tinted officer has been appointed as the IIC of this model police station.
- The DCP is not inspecting the police station as per the provision of the Odisha PMR No. 37(a)
- The DM is not inspecting the police station as per the provision of the Odisha PMR No. 21

I request a thorough investigation into these matters. The lives of inmates are at stake, and justice must prevail as above mentioned facts and only the gist of the whole affairs
